- The Tender Documents with quoted offer should be placed in a sealed cover with the name of the Tenderers and the name of the work subscripted on it and titled "Application for IT Development & Support for AIFF". Supporting documents as required above should be enclosed with the offer. Bids have to be submitted online at <a href="mailto:aiff@the-aiff.com">aiff@the-aiff.com</a>. Only bids which are both online and offline submitted within the due time will be considered valid.
- Please note that 'Technical Bids' and 'Financial Bids' need to be submitted in separate envelopes, which can further be included in one large envelope.
- Sealed tenders shall be deposited in the Tender Box at the Reception Desk, All India Football Federation, Football House, Sector 19, Phase 1, Dwarka, New Delhi 110075, on the date and within the time indicated above. The tender shall also be submitted online by the deadline at tender@the-aiff.com. Tender applicants who have submitted both online and offline submissions shall be the only ones considered for the instant tender allotment.
- Tender is open to the eligible Vendors/Firms of appropriate class and skills.
- Tenders will be opened by a Tender Opening Committee constituted as prescribed by the AIFF.
- The Tenderer should sign on every page of the Tender Documents as acceptance of the general direction and conditions of contract and other laid down norms. The rate quoted should be both in figures and words and should be inclusive of Goods and Service Tax and all other Taxes and Levies. Over writing and correction should be avoided and if made should be authenticated. In the incidence of discrepancy in figures, the rates given in words shall prevail. Incomplete/conditional tenders shall be rejected forthwith.
- Avoidable damages due to negligence of the contractor shall be at his own risk and cost. The Department shall not be liable for payment of such damages (if any).
- The tender offer shall remain valid for a period of 30 days.
- All the conditions as mentioned in the Notice shall be deemed to be a part of the agreement to be entered with the contractor/vendor.
- The Department reserves the right to accept/reject any or all tenders without assigning any reason thereof.
- Subletting of contract work is against the norms and if it comes to the notice, the original contract shall be cancelled, and appropriate action shall be initiated as per the rules.
- In case the manpower employed by the contractor is from outside the state or





neighboring countries, it shall be the responsibility of the contractor to get them registered with the Labor Department, Government of India, as per the relevant labor laws.

- It is expected of the tenderer to have its own correct assessment before submitting the bid.
- The contractor will have to pay all taxes and duties applicable and notified by the State/ Central Government and no claim shall be entertained in this regard whatsoever.
