



## NOTICE INVITING TENDER

For and on behalf of the All India Football Federation (AIFF), sealed tenders are invited from vendors providing transport services (taxi/bus).

### INTRODUCTION

The All India Football Federation, commonly referred to as AIFF, is the governing body for the sport of football in India. Established in 1937, the AIFF is responsible for organizing and developing football at all levels across the country. It is affiliated with the Asian Football Confederation (AFC) and FIFA (Fédération Internationale de Football Association), the global governing body for the sport.

We, at the AIFF, are looking for hiring an appropriate agency that provides transport services (taxi/bus) for a period of two years.

### SCOPE OF WORK

# CONDITIONS OF CONTRACT

• The intending vendors should apply in writing applying for the instant tender. The application would invariably be signed by the contractor himself/herself. The application shall be submitted for the work listed above with all required documents & information as indicated under.

BIDS

• The Tender Documents with quoted offer should be placed in a sealed cover with the name of the Tenderers and the name of the work subscripted on it and titled "Application for Transport Services for AIFF". Supporting documents as required above should be enclosed with the offer. Sealed tenders including Technical and Financial Bids shall be deposited in





the Tender Box at the Reception Desk, All India Football Federation, Football House, Sector 19, Phase 1, Dwarka, New Delhi – 110075, on the date and within the time indicated above.

- Both the Technical and Financial Bids have to be submitted online at legal@the-aiff.com. Only bids which are both online and offline submitted within the due time will be considered valid.
- The Technical bid should be submitted in the prescribed application form (Annexure I) and the Financial Bid should be submitted in the prescribed application form (Annexure – II). Both the Technical Bid and Financial Bid should be signed and stamped by the authorized person. The Technical Bid should be superscribed as "TECHNICAL BID FOR SUPPLY OF TAXIES/BUSES" as mentioned in Annexure I and the Financial Bid should be superscribed as "FINANCIAL BID FOR SUPPLY OF TAXIES/BUSES" as mentioned in Annexure II.
- Tender is open to the eligible Vendors/Firms of appropriate class and skills.
- Tenders will be opened by a Tender Opening Committee constituted as prescribed by the AIFF.
- The Tenderer should sign on every page of the Tender Documents as acceptance of the general direction and conditions of contract and other laid down norms. The rate quoted should be both in figures and words and should be inclusive of Goods and Service Tax and all other Taxes and Levies. Over writing and correction should be avoided and if made should be authenticated. In the incidence of discrepancy in figures, the rates given in words shall prevail. Incomplete/conditional tenders shall be rejected forthwith.
- Avoidable damages due to negligence of the contractor shall be at his own risk and cost. The Department shall not be liable for payment of such damages (if any).
- The tender offer shall remain valid for a period of 30 days.
- All the conditions as mentioned in the Notice shall be deemed to be a part of the agreement to be entered with the contractor/vendor.
- The Department reserves the right to accept/reject any or all tenders without assigning any reason thereof.
- Subletting of contract work is against the norms and if it comes to the notice, the original contract shall be cancelled, and appropriate action shall be initiated as per the rules.
- In case the manpower employed by the contractor is from outside the state or neighboring countries, it shall be the responsibility of the contractor to get them registered with the Labor Department, Government of India, as per the relevant labor laws.
- It is expected of the tenderer to have its own correct assessment before submitting the bid.
- The contractor will have to pay all taxes and duties applicable and notified by the State/ Central Government and no claim shall be entertained in this regard whatsoever.

# EARNEST MONEY DEPOSIT (EMD)

• EMD of Rs. 10,000/- (Rupees Ten Thousand Only) in the form of Demand Draft/Pay Order/Banker's Cheque from any Nationalised /Commercial Bank in favour of ALL INDIA





FOOTBALL FEDERATION payable at New Delhi, must be submitted with the bid. Bid without EMD and in any other form will not be considered and the bid shall be rejected.

- The EMD shall be without interest and no interest shall be payable during the period of holding with AIFF for completion of tender process.
- The EMD should remain valid at least for a period of 45 days beyond the final tender validity period.
- EMD of the bidder will be forfeited, if the bidder withdraws or amends its bid in any respect within the period of validity of its bid.
- EMD without interest, shall be collected by all unsuccessful bidders from "Football House" after completion of tender process within 30 days.

# OTHER TERMS AND CONDITIONS

- The vehicles provided should be authorized to be used as taxies and should have proper permission of the areas to be traveled in Delhi/NCR and other cities and should not be more than 3 to 4 years old. The contractor should be able to provide taxies at a short notice/within 1-2 hours.
- The drivers engaged in the taxies should have valid driving commercial license to operate the taxi. Other necessary documents like copy of the Road Tax Clearance Certificate, Pollution Certificate, Insurance etc. should be available in the assigned vehicle. The drivers should always be in the uniform as may be provided by the agency with mobile phones and should be well mannered. The driver engaged should be broadly familiar of the major routes of Delhi/NCR/other cities.
- In case of any break down while on journey, alternative arrangement shall have to be done by the contractor failing which the taxi will be hired from the open market and the expenses incurred thereon shall be deduced from the monthly bill of the contractor.
- The AIFF reserves the right to terminate the contract without assigning any reason by giving the contractor one calendar month notice of its intention to do so.
- Billing will start from and end with office premises or designated place and not from & with the taxi stand. The vehicle may directly report to the designated person/officer when asked to report an officer at residence or at designated place where meter reading should be got noted by the user and duty slip should be got signed by the user along with additional signature on closing meter reading.
- In case of hiring of taxies, 40 km or 4 hours shall be considered half day. In case, if the vehicle is detained above 4 hours, then it shall be treated as full day duty.
- Decision of the Tender Opening Committee regarding acceptance or rejection of tender will be final and binding.
