DECISION

The Court of Arbitration for Sport rules that:

- 1. The appeal filed on 4 June 2025 by Inter Kashi FC against the decision issued on 31 May 2025 by the Appeal Committee of the All-India Football Federation is partially upheld.
- 2. The decision issued on 31 May 2025 by the Appeal Committee of the All-India Football Federation is set aside.
- 3. The AIFF shall forthwith adjust the points table of the I-league 2024-25 season as follows:

Position	Team	Points
1.	Inter Kashi FC	42
2.	Churchill Brothers FC	40
<i>3</i> .	Real Kashmir FC	37
4.	Namdhari FC	29

- 4. The AIFF shall forthwith declare Inter Kashi FC as winner of the I-league 2024-25 season.
- 5. The costs of the arbitration, to be served to the Parties by the CAS Court Office separately, shall be borne for 55% by the All-India Football Federation, 15% by Churchill Brothers FC Goa, 15% by Namdhari FC and 15% by Real Kashmir FC.
- 6. The All-Indian Football Federation shall pay an amount of CHF 3,000 (three thousand Swiss francs) and Churchill Brothers FC Goa, Namdhari FC and Real Kashmir FC shall each pay an amount of CHF 1,000 (one thousand Swiss francs) to Inter Kashi FC as legal contribution towards its legal costs and other expenses incurred during these arbitral proceedings.
- 7. All other and further motions or prayers for relief are dismissed.
